



### Hexavalent Chromium (Cr(VI)) Testing Flow Chart







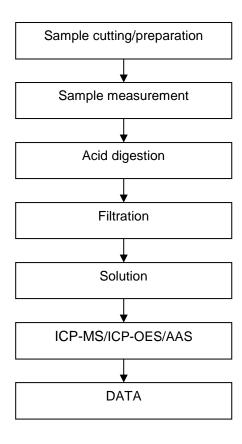

### **Elements Testing Flow Chart**






